## Regular Meeting Minutes October 4, 2022

### **Call Meeting to Order**

Chair Rhine called the meeting to order at 5:30 p.m. Commissioner Lyons and Commissioner Gibson were in attendance. Also present at the meeting were District Administrator Jennifer Bethke, Deputy Administrator Chris Cohen and VFD Chief Brennan Blue. Riza Russum recorded meeting minutes.

#### **Approval of Minutes**

Commissioner Lyons motioned to approve the September 6, 2022 regular meeting minutes as submitted. Commissioner Gibson seconded the motion. All were in favor. The motion passed.

#### **Chief's Report**

VFD Chief Brennan Blue reported they are busy working through the current budget. Administrator Bethke asked the Chief if there has been any progress with the county on collecting impact fees. Chief Blue replied not at this time, but, it will come up again in 2023.

- C. <u>Staff Report 2022-054 Budget Considerations –</u> Based on granting COLA, the board discussed significant increases in inflation and its effect, not only on district employees, but how other agencies have handled this for 2023. After some discussion, Commissioner Gibson moved to approve a 7% Cost of Living Allowance (COLA) for 2023 for regular employees. Commissioner Lyons seconded. All were in favor. The motion passed.

The medical premiums for the PPO 100 plan will increase 2.5% in 2023. Commissioner Lyons moved to continue paying the full medical premiums for six full time employees. Commissioner Gibson seconded. All were in favor. The motion passed.

### **Board Communications**

<u>Firefighter Retirement</u> – Commissioner Gibson attended the Vancouver Firefighters' IAFF Local 452 retiree and awards ceremony. Mary Elkin was recognized as an honorary member for her community support for many years.

<u>WA State Auditors</u> – Administrator Bethke reported to the board that the State auditor's office will audit years 2019-2021 starting the week of October 31.

**Station 11 Grand Opening** – Fire District 5 staff and commissioners will attend the Station 11 grand opening on October 22. Commissioner Rhine will give a short speech on behalf of the District.

**SWFC Meeting** – Commissioners Rhine and Lyons and Administrator Bethke will be attending the meeting on October 5 in Kelso, WA.



<u>District Contingency/Ongoing Planning</u> – Chair Rhine opened a discussion on the long term plans for the District. This topic included succession planning and annexation possibilities as well as District contributions to VFD over the next 5, 10 and 20 years. Contingency plans were also discussed pointing out the need to anticipate any adverse eventualities. Commissioner Rhine suggested a strategic planning workshop to further deliberate. Chief Blue suggested bringing the City Planner for expert input.
