FUNDING WILDLAND URBAN INTERFACE TRAINING

Background: The Board of Fire Commissioners of Clark County Fire Protection District No.5 has a Contract for Services with the City of Vancouver where the Vancouver Fire Department (VFD) provides all Fire Suppression and Emergency Medical Services in Clark County Fire Protection District No. 5's service area. The City of Vancouver has initiated budget cut exercise across the City, including Vancouver Fire Department. The Chief of VFD has requested Clark County Fire Protection District No. 5 fund the upcoming 2024 Wildland Urban Interface Training for Deputy Chiefs, Division Chiefs, Battalion Chiefs and Captains.

As many areas within the District are located in Wildland Urban Interface response areas, this funding will benefit the District's taxpayers and overall safety of those served.

Resolution: NOW THEREFORE, BE IT RESOLVED that the Board of Fire Commissioners of Clark County Fire Protection District No. 5 hereby authorizes the funding of Wildland Urban Interface Training in the amount up to \$75,000 from the District's Special Revenue Fund 6256, payable to Vancouver Fire Fund 151.
